# **Coal dust must be declared** an urgent health disaster

UR recent front page article (Port pollution problem, 15 September 2025) referred to the Transnet Integrated Report stating that dust pollution at the Port of Richards Bay had reached serious levels.

TNPA admitted that its present operations and future expansion plans were at risk due to potential non-compliance issues which could have legal and punitive implications.

Worryingly, the report said the aim was to reduce complaints not emissions! – by 30%.

The fact of the matter is that people have become tired of logging official complaints as a perceived waste of time, since the situation remains unchanged.

Richards Bay residents, particularly in Alton and Arboretum, have all but given up on seeing any change in the amount of coal dust generated, which they are forced to sweep and clean a few times a day.

They see ever more permits being issued for uncovered stockpiles of coal adjacent to roads and businesses, and suffer contamination of their own products.

The dangers have hardly been addressed, and the warning temperature has long ago risen from orange to red.

It's now the windy season, and the black dust is being spread far and wide, affecting not only the industrial area, but also the suburbs of Richards Bay.

Black soot settles everywhere, and homeowners are subjected to layers of dirt and grime, both indoors and outdoors.

From roof level to gardens to the bottom of swimming pools, the ubiquitous dust is demanding cleaning be done three or four times a day to make homes properly habitable.

# Comment

But the inconvenience is nothing compared to the possible health impacts.

Not only are the dust particles small enough to enter and irritate the lungs, some products that are being blown around and inhaled are corrosive and some have been proven to have metal content.

One shudders to think of the long-term effect on residents, especially those with respiratory problems; not to mention the young whose lungs are still developing.

Online platforms are increasingly filled with complaints over respiratory issues.

The responsible authorities are silent over this incredibly serious environmental and human health risk, while the medical profession treats symptoms without adding its important voice and input to the public debate and outcry.

To say we have a local state of emergency is no exaggeration.

While patients are privately being told that their asthma, sinus problems, lethargy, coughing, sneezing, itching, eye and throat irritations are directly linked to coal dust pollution, the matter is taken no further.


There are government departments whose job it is to ensure our right to clean air, and to monitor and take action with regard to the state of the environment.

On top of all this, we recently learnt that, apart from the records and data supplied by the Richards Bay Clean Air Association, none of KZN's air quality monitoring stations are operational.

The matter needs at the very least to be taken to Parliament, to become subject to a proper investigation.


